



**Military Family Appreciation Day Family Release, Assumption of Risks & Indemnification** (rev 10/18)

We're thankful to have you join us!

We ask that you read and consider this document closely as it affects your legal rights.

The reason we are asking you to assume specific risks and waive certain legal rights is because many of the recreational activities at camp are dangerous. Injuries happen; CRISTA cannot guarantee participant's safety or lack of injury. Participating in camp activities carries inherent risks, and we want to describe some of those risks so that you may make informed decisions regarding you or your child's participation. **This Agreement constitutes the entire agreement between the parties.** If any portion of this agreement is found to be void or unenforceable, both parties agree that the remaining portions shall remain in full force and effect.

**Assumption of Risks:** I acknowledge and understand that camping activities are inherently dangerous to me or Minor(s). Activities like: skating, skateboarding, paintball, ropes courses, archery, marksmanship, water activities, the use of horses or dirt bikes, etc., are hazardous and dangerous activities that require strenuous exercise and varying degrees of skill and experience. Often injuries can occur in skating and skateboarding relating to slips, falls, or collisions. Paintball and archery run risks associated with projectiles causing injury such as loss of sight. Students may fall from or get tangled in ropes courses, leading to injury. Water sports have the added risk of water and the potential for injuries resulting in oxygen deprivation or drowning. Mounting, dismounting, and riding horses or dirt bikes carry risks of injury from falls, collisions, being run over or trampled, or other means of injury. These descriptions are not exhaustive, but are illustrative of the possibility for serious injury, disability, or even death, to occur. I understand that camp activities can result in serious injury to the person and damage to property; I voluntarily assume all risks of loss, damage or injury while on the premises for myself and Minor(s). **Waiver, Release & Covenant not to Sue:** In consideration for my participation, or for the participation of Minor(s) for whom I represent that I am legal guardian, I hereby release and forever discharge Island Lake Camp, Miracle Ranch Camp, and CRISTA Ministries, and their employees, officers, trustees and all other persons or entities acting on their behalf (collectively referred to as "CRISTA"), from any and all claims, actions, damages, liabilities, costs or expenses and attorney fees which are related to, arise out of, or are in any way connected to my, or Minor(s), viewing or participation in any camping activities. By signing this Agreement, it is my intention to waive any rights I have to sue or seek damages from CRISTA; except where injury, death or disability results from CRISTA's gross negligence, intentional or reckless misconduct, or any other liabilities that Washington law does not permit to be excluded by agreement. I further covenant not to sue or bring a legal claim on behalf of Minor(s) against CRISTA for all claims, actions, damages, liabilities, costs or expenses and attorney fees which are related to, that are in any way connected to Minor(s)' participation or involvement with camp activities; except where injury, death or disability results from CRISTA's gross negligence, intentional or reckless misconduct. **Image Release:** CRISTA may publish any photos or video images taken of me or Minor(s) without my consent, and I release all rights to any remuneration for such photos.

**I REPRESENT THAT I HAVE CAREFULLY READ THE FOREGOING AND ACKNOWLEDGE THAT I VOLUNTARILY UNDERSTAND AND AGREE TO ALL THE TERMS AND CONDITIONS. I HAVE HAD THE OPPORTUNITY TO ASK ANY QUESTIONS. I AM AWARE THAT BY SIGNING THIS AGREEMENT, I ASSUME ALL RISKS AND WAIVE AND RELEASE CERTAIN SUBSTANTIAL RIGHTS THAT I HAVE OR POSSESS.**
